# Treasurer (Paul M.):

Hello Family, thank you for allowing me to be of service. I was glad to gain experience as the Area treasurer over the last year, and appreciate everyone's patience as I learned the ropes. Please note that there are two pages to this report.

This is the end of my term as Treasurer. Thank you again for allowing me to be of service.

We are still on decent financial footing.

I am concerned about the various entities in our Central Ohio Area Service Committee, and still <u>strongly</u> <u>suggest that we consult with a qualified professional. Here are a few things I suggest we seek guidance on from a tax and insurance specialist who has experience with non-profit groups like ours:</u>

- Is it possible for COASCNA to be insured under the Region policy (ORSCNA) when we are completely separate entities?
- Is there anything we need to be aware of since there are three separately incorporated groups within the Central Ohio Area?
  - o COASCNA
    - Our service committee, made up of subcommittees such as H&I and Public Relations and which performs duties on behalf of the many Groups in our Area; will be required file Federal tax returns.
  - o COAONA
    - The Area Office, which conducts business reselling literature, but whose office insurance, rent, and phone/internet is currently paid by COASCNA; COAONA also must file tax returns
  - o COACNA
    - Technically a subcommittee of COASCNA; it's the every-two-year Area Convention, which provides COASCNA with some portion of its proceeds from the Convention. On the flip side, COASCNA could be responsible for any financial loss the Convention suffers. COACNA has to file tax returns.
- Are the assets of individual trusted servants at risk if we do not have adequate coverage?
- Should the Executive Body of the Area be named in an insurance policy (the same as the executive body of the Region is named in their insurance policy, or at least was in the last policy our Area was easily able to view)?

I have talked to trusted servants from a few other Areas and Regions across the US, and they all offer the friendly strong suggestion that we sit down with a professional to make sure that we acting in accordance with all applicable laws and regulations, and that trusted servants are at no risk of personal liability.

#### Other items to note:

- The ASC Chair has set up a PayPal account so that groups can make electronic donations to Area.
  - See main menu of website
    - COASCNA has set up electronic donations so NA members and groups can donate more easily. Please note our 7th Tradition states that "Every NA group ought to be fully self-supporting, declining outside contributions." We are unable to accept any donations from non-addicts due to our principle of self-support.
    - Interested members and groups can donate with PayPal to coascna.treasurer@gmail.com

- Anyone can set up a PayPal account as long as there is a valid email address and checking account or credit card associated.
- Make sure to add a note to indicate which group or person is sending the money so it can be attributed to the correct group.
- The donations from our groups have decreased sharply over the last few months; here are some expenses to consider, and for the Groups to think about how they want to direct Area to proceed over the coming months.
  - o Fixed costs for goods and services (~\$5,000 per year, or \$417 per month)
    - Area Office (\$4,650 per year)
      - Rent, \$250 per month (\$3,000 per year)
      - Phone & internet, \$100 per month (\$1,200 per year)
        - This is a combined, single bill. It is possible to get a much cheaper phone plan and not have internet included.
      - Insurance for the office only, ~\$450 per year
    - Public Relations / Information (\$330 per year)
      - Website, \$330 per year
  - Variable costs (costs we can suspend)
    - Literature for the H&I Committee
    - For the PR subcommittee: Literature, fees for tables at evens like African American Male Wellness Walk and Gay Pride, NA Awareness Campaigns such as radio spots, PSAs, billboards, and program listings such for Comfest
    - Rent for JFT if ASC begins meeting in person (\$300 per year), or
      - if ASC continues to meet virtually, then the cost of the virtual platform (Zoom, Bluejeans, etc.) or
      - Investigate free alternatives.
    - Unity Day
    - Addithon
    - New Year's Eve
