Hey Family,

Carrying the message goes beyond our own groups, thus the need for an Area Service Committee. I have asked for you all to wear more than one hat. Most of the ASC are already serving in multiple positions. Thank you for supporting this organization. Many groups need support, trusted servants, and guidance.

Established meetings are reopening and new meetings are starting up as COVID numbers decline. These meetings may be meeting in different locations and at different times. As we no longer publish a schedule, it is difficult for our members to know where and when these meeting are. We can always point them to our website, but we can also spare a moment to tell them about a meeting. Can we go to an extra meeting that needs support? It is unacceptable for this meeting to take 4 hours or more. Even the most dedicated servant should not be asked to spend that much of their Sunday. I hope everyone had a chance to read the email I sent out on January 26th. If you have any questions or concerns about Consensus Based Decision Making feel free to reach out to me. Also, please do not asked to be recognized to just agree with an opinion that has already been given. If you have a different opinion to offer it will be given the attention it deserves. Personal attacks will not be tolerated. Let's all remember that we are all here because we want to serve this program.

We are re-establishing connections with our 23 commitments and adding a new commitment this month at Ohio Addiction and Recovery. I have provided a new printed lists of facilities and panel members so that GSRs could distribute these at their homegroup business meetings. Activities/info since last ASC meeting in January

- Website traffic in January increased significantly compared to December, due in part to people finding information about COACNA
 - o Web stats for January: 3,171 visitors, who viewed 11,100 pages
 - o Year to date: 4,797 visitors, who viewed 16,900 pages
- Please continue to send all meeting updates to COASCNA@gmail.com, and include as much detail as possible. Groups are encouraged to review the information about their meetings on the website to confirm that all information is accurate, including the virtual meeting link and passcode (if any).
- Quarterly budget request sent to treasurer:
 - o Pending: January – March 2022: \$2,300 for billboards
 - o April – June: \$500 for tables/presence at summer festivals (Comfest, Gay Pride, African-American Male Wellness Walk, etc.)
- Had meetings with trusted servants in Florida and Alabama to share best practices and lessons learned when working with prison officials to provide free NA resources on the computer tablets of the incarcerated in their respective states; responded to requests from PR trusted servants in the Plain States Zone of NA to share information about eLit on prison tablets
- In collaboration with WSR (Writing Steps for Recovery subcommittee), information on how to get paired with an NA member who will serve as a step guide was pushed out to the computer tablets of those incarcerated in the ODRC (Ohio Department of Rehabilitation and Correction). To date nearly 70 letters from incarcerated Ohioans have been received.
- Started working with COANA H&I subcommittee in September 2021; sent the Chair a video from the United Kingdom's NA Fellowship that is getting shown on prison monitors there. Discussed with the Chair the possibility of H&I here doing the same thing. H&I committee members watched the UK video and discussed the possibility in October. In November I attended the H&I subcommittee meeting to help brainstorm what a video could look like (duration of video, how it could get pushed to the tablets, timeline, etc.). I contacted the H&I Chair who said that a video is ready, and that more are planned. We will work together to get these pushed out to tablets.
 - o UPDATE: Video received from H&I Chair, and forwarded to the ODRC (Ohio Department of Rehabilitation and Correction) for review, who says that it should be fine, but they will need to get confirmation from OHMAS (Ohio Department of Mental Health and Addiction Services).
- On 02/07/2022 presented to 8 fourth-year medical students at The Ohio State University. These students will soon be practicing physician residents in our communities. A few of them knew that NA existed, but most did not, and none of them had foundational knowledge of our program. Over the course of their careers they will touch thousands of lives, and we are grateful that they now know about NA and how it could help their future patients. This is the third year PR has been doing these presentations which have reached close to 600 medical students. Many of them choose to attend open virtual and/or in-person NA meetings to learn more about our program and to fulfil a portion of their course requirements.

- In the process of getting IPs pushed out to the Department of Youth Services facility
- Exploring feasibility of using the BMLT (Basic Meeting List Toolkit) on website to facilitate meeting updates to nacentralohio.org, naohio.org, and na.org
- Possible PR virtual learning day Spring 2022
- An event tentatively called "Predecessors Day" in the summer of 2022. Planning is in early stages. There is a notebook that has entries from addicts sharing their experience in the Fellowship over the last few decades, which could be something to highlight at the event.

Writing Steps for Recovery: (Kelle A.)

Greeting's area service members,

To follow up on last month's report. My apologies, I forgot to send the follow-up email with receipts attached for what we had spent so far, so that is included here.

Our big news. Since last month, we have been pushed out to the prison tablet system statewide. Although this was not our original intention, we have received a big response from incarcerated addicts and have every hope that recovering addicts in our area and beyond will lean into this exciting area of service and sign up to answer this need for addicts seeking recovery. So far, we have received 94 letters. 63 from men and 31 from women. We are currently reviewing and refining our original processes to accommodate how our information went out and be able to serve the addicts that are writing to us in the best ways possible. We are excited to be in this season of moving forward, and are seeking everyone's help to get the word out that we need people to sign up to be Step Guides. We are happy to have people in and outside our area, and will have the opportunity to either pick up mail at the area office or have mail forwarded depending on the situation.

We are also excited to have had PR help us with a resource sheet that will now be included and going out to every individual who writes to us.

Our biggest need is Step Guides. Please join us in inviting new Step Guides by announcing at every meeting and function you attend, and reaching out to any and everyone in your contact list that we are looking for people who are willing to work steps by mail with incarcerated addicts seeking recovery. Simple go online at the area website under the WSR tab and fill out the application to begin the process. Feel free to reach out to us by email or to any of our members with listed phone numbers. We are happy to answer further questions. Or simply stop by our meeting, which is the second Thursday of the month on zoom at 5:30. We look forward to seeing you soon!
